

## **ASSUMPTION OF RISK and RELEASE OF LIABILITY AGREEMENT**

## This Document Affects Your Legal Rights – YOU MUST READ IT CAREFULLY

I, \_\_\_\_\_\_, hereby affirm that I am aware that playing touch football has inherent risks which may result in serious injury or death. I hereby personally assume all risks, whether foreseen or unforeseen, that may befall me while I am a participant in MTFL sanctioned events (which term includes games, scrimmages, and practices).

In consideration of being allowed to participate in MTFL sanctioned events, I hereby RELEASE, SAVE HARMLESS, and INDEMNIFY the MTFL (which term shall include the MTFL, its executives, officers, directors, agents, representatives, contractors, and employees, and their respective heirs, executors, administrators, estate trustees, successors or assigns), from and against all manner of claims, actions, applications, and demands, made in respect of death, injury, loss, or damage to my person or property, however caused, arising out of, or in connection with, my participation in MTFL sanctioned events, and notwithstanding that the same may have been contributed to or occasioned by any act or failure to act (including, without limitation, negligence) by the MTFL.

I agree that I will **not** make any claim against any person, firm or corporation who might claim contribution or indemnity under the provisions of the *Negligence Act* and any amendments or successor thereto from any of the parties having benefit from this release.

I also agree to abide by the rules, regulations, and by-laws of the MTFL currently in force and which may be amended from time to time, and I have read and agree to abide by the MTFL Code of Conduct (*asummary edition has been included below and the full edition of it is posted on the league's website*). I further state that I am of lawful age and legally competent to sign this liability release. Specifically, the MTFL is an adult touch football sports league requiring any such person registering with it to have already attained their eighteenth birthday before they may participate in any MTFL-sanctioned event.

I ACKNOWLEDGE THAT I HAVE HAD AN OPPORTUNITY TO FULLY INFORM MYSELF OF THE CONTENTS OF THIS ASSUMPTION OF RISK AND RELEASE OF LIABILITY AGREEMENT. ON BEHALF OF MYSELF AND MY HEIRS, I HAVE READ THIS ASSUMPTION OF RISK AND RELEASE OF LIABILITY AGREEMENT CAREFULLY AND UNDERSTAND IT.
